September 17, 2024

Supervisor Koshar called the meeting to order at 6:00pm and Debra Hess led the pledge of allegiance.
Roll Call: Koshar, Hess, Mroz, Schick, and Plummer

Motion by Schick, seconded by Hess, to approve the agenda as presented. All Ayes – motion carried.

Motion by Koshar, seconded by Hess, to approve the minutes from the August 20, 2024, meeting as presented. All Ayes – motion carried.

Motion by Schick, seconded by Koshar, to approve the minutes of the Special meeting on September 5, 2024. All Ayes – motion carried

Motion by Koshar, support by Mroz, to pay the bills as presented. Roll Call: Ayes: Koshar, Schick, Mroz, Hess, and Plummer. Motion Carried
